



PHYSICIAN'S DISCLOSURE OF FINANCIAL INTEREST

Indiana law (I.C. 25-22.5-11) generally requires a physician to make certain written disclosures to a patient when the physician refers the patient to a health care entity in which the physician has a financial interest. While you are a patient (or the patient for whom you are the legal representative is a patient), an Ascendant Orthopedic Alliance physician, may refer you to one of the health care entities listed below in which he/she may have a financial interest.
